1. General Product Description

Lastogrip® is an elasticated tubular bandage, exerts uniform, medium-strength pressure, quick and easy to apply without additional fixation, fit perfectly without slipping, may be removed as often as required and re-applied, kind to the skin due to a high content of cotton fibres; may be washed and sterilized.

Lastogrip® carries the CE mark according to EU directive 93/42/EEC for medical devices.

The product is classified as a class I medical device unsterile.

A conformity assessment has been performed for Lastogrip® and it has been shown to be in compliance with all applicable requirements of the above mentioned directive.

The safe use of Lastogrip® therefore, is ensured if the product is used in line with the intended purpose (see 2. Application/Indication).

- Stronger compressing fixation bandages, e.g. in Thoracic and Abdominal surgery
- For post Mamma-OP bandages
- For wide abrasions to avoid oedema at the wound border respectively to relieve the wound
- As supporting and relieving bandage for damaged of the attitude and movement apparatus
- As supporting thermal bandage for arthrosis, and so on
