1. General Product Description

Visulin® is a selfadhesive, sterile and transparent wound dressing based on a polyurethane film coated with acrylic adhesive.

The film is permeable to air and moisture vapour. It is repellent to bacteria and liquids.

The application of Visulin® can easily be made with detachable support liners at two edges of the dressing.

Visulin® carries the CE mark according to EU directive 93/42/EEC for medical devices. The product is classified as a class IIa medical device.

A conformity assessment has been performed for Visulin® and it has been shown to be in compliance with all applicable requirements of the above mentioned directive.

The safe use of Visulin®, therefore, is ensured if the product is used in line with the intended purpose.

2. Application / Indication

For fixation of peripheral, endovenous catheters, of absorbent dressings, of nozzles. Sterile covering and protection of dry, or slightly exuding and not infected wounds. The big dimensions of Visulin® dressings can also be used as drapes for incising.
