5. Classification/Safety Aspects

In the Federal Republic of Germany MoliCare Skin Zinc Oxide Cream is classified as cosmetic product. The product is in compliance with the latest amendments of the European Directive on Cosmetics (EEC Council Directive 76 / 768 with Technical Adaptations and Amendments). The product contains only ingredients which are permitted resp. which are not prohibited for cosmetic use according to the EEC Directive on Cosmetics.

The skin tolerance was dermatologically tested on predamaged (scarified) skin of human subjects with the result "very good" as well as on persons with atopic dermatitis in eczema free interval with the result "Well compatible with all test persons. In no case there were any undesirable reactions".

Combined with a cleansing product of the MoliCare Skin series the Zinc Oxide Cream was tested in a nursing home on persons suffering from incontinence under supervision of a medical specialist. The combined application of the products resulted in an improvement of the skin condition. Furthermore the very good skin tolerance and the protection effect of MoliCare Skin Zinc Oxide Cream against harmful substances in stool and urine could be attested.
